LIMITATION OF CARRIERS LIABILITY

In consideration of the charges for the movement of any shipment, it is agreed that the liability of **EZONE** shall be limited, in any event, to the sum of \$100.00 US Dollars.

No liability whatsoever is assumed for the delay in delivery or for consequential damages of any kind, such as loss of income, loss of interest or, loss of business opportunity, or any loss or damage arising from the inherent nature of the goods.

EZONE does not agree to carry and it is agreed that **EZONE** accepts no liability for items of unusual intrinsic value such as cash, negotiable securities, jewels, furs or like.

Our method of operation includes inter alia carrying on board the aircraft, accompanied passenger baggage and unaccompanied air freight. The term "Courier Service" does not necessarily imply that a man will be on board the aircraft.

In the event that the Customer fails to make payment within 30 days after balance is established, said balance shall bear an additional service and handling charge at the rate of 1 1/2% per month and **EZONE** may, as its option, turn the said balance over to an attorney for collection and there shall then be added to the balance due, as and for the attorney's fees, either the actual fee to be paid to the attorney for his services or the minimum fees recommended by the local Bar Association, whatever is less or sell said items for recovery of balance outstanding.
